REQUEST FOR TRANSFER OF F-1/J-1 SEVIS RECORD FROM THE UNIVERSITY OF ALABAMA

Homeland Security requires that an international student's eligibility to transfer to another institution in the United States be confirmed prior to the issuance of new immigration documents. Part 1 should be completed by student who is transferring out of The University of Alabama and submitted to ISSS with a copy of the Admission Letter from the new institution.

IMPORTANT: Students must maintain an active/valid status until the time of transfer. Students not in an active/valid status will be transferred in a terminated status and will have to seek F-1 Reinstatement or J-1 Reinstatement through the new institution. If the new institution will not accept a terminated SEVIS record, the student will have to seek a new SEVIS I-20/DS-2019 for initial attendance from that institution and travel abroad and re-enter the U.S. on a valid visa to obtain F-1/J-1 status.
